The Role

The post-holder's primary responsibility will be to manage and lead the team, and guide, mentor and monitor all initiatives and projects of the Foundation and operations as per its agreed priorities. This will also involve providing thought leadership and represent the Foundation whenever necessary. The position is based in Bhubaneswar, and knowledge of Odia is desirable, but not mandatory. Responsibilities

- Fundraising strategy and implementation: Develop and execute optimal fundraising strategies to secure philanthropic and impact investment support for the Foundation's initiatives.
